The Philatelic Bureau of the Department of Posts will issue a new postage stamp in the denomination of Rs. 1/- on 13th January 1992, to commemorate the launching of the "Sri Lanka Year of Exports 1992".

His Excellency the President has declared 1992 as "The Sri Lanka Year of Exports". The broad objective of this declaration is to pave the way for the achievement of a growth rate so that Sri Lanka could join the ranks of the Newly Industrialised Countries (NICs) within this decade.

In a liberalised economy the development of the country depends on a strategy of export led growth. Such a strategy would contribute towards industrialisation, and a state of full employment, thereby enhancing the living standards and quality of life of the people.

In order to ensure an expansion of exports at a rate of 10.3 in real terms during the year 1992, the following activities will be launched:

(a) The creation and maintenance of an appropriate policy framework in order to attract more entrepreneurs into the export sector, as well as to improve the competitiveness of exports in international markets.

- (b) Identification of new markets and disseminating market information.
- (c) Developing and broad-basing supply capabilities.
- (d) Investment promotion for export led industries.
- (e) Removal of disincentives and constraints in export activities.
- (f) Removal of cumbersome and inhibiting export procedures.
- (g) Improvement of infrastructure facilities.
- (h) Enhancing and developing managerial skills.
- (i) Creation of (i) an export awareness among the general public and (ii) a commitment to the facilitation of exports among relevant government officials.
- (j) Implementation of a promotional programme to develop the image of Sri Lanka as a reliable supplier of quality products and a politically stable country to invest in.
- (k) Implementation of a programme of activities of an international nature throughout 1992, within Sri Lanka, in order to focus attention on "The Year of Exports".
